### Please read, review and follow the instructions in this notice carefully.

At Honeywell, our mission is to be the reference leader in personal protective equipment that innovates to protect and save lives worldwide every day. In line with our commitment to our mission statement, we are writing to inform you of a quality issue with a stainless steel anchor shackle, which is a component of our SkyGrip® Stainless Steel Permanent Horizontal Lifeline Kits and Xenon® Horizontal Lifeline Kits. The following information provides detailed instructions on immediate actions you are required to take.

Please note, SkyGrip kits with stanchions and kits with galvanized lifelines are <u>not</u> included in this notice.

#### Situation:

We recently received a safety notice from a customer regarding the stainless steel shackle. An issue with a specific lot was identified in the customer's pre-use inspection. The details concerning this problem are set forth below.

The lot in question can be identified through a visual inspection. This lot was potentially sold between November 15, 2008 and March 15, 2011 and has the heat code designation "**G24**" stamped on the backside of the shackle.

The stainless steel shackle was incorrectly heat treated, and under very corrosive conditions, it may develop internal stresses which could lead to premature failure. You must immediately inspect the products listed below with dates of manufacture between November 15, 2008 and March 15, 2011. If the product has a stainless steel anchor shackle with the "G24" heat code, you must discontinue use of the product until the anchor shackle has been replaced.

We are replacing all anchor shackles affected by this notice at no charge.

- 2. To obtain a no-charge replacement stainless steel anchor shackle, please be prepared to provide the following:


Quantity of affected product and Shipping instructions (i.e. Company name, address, phone number, ship to attention)

3. The Technical Service Representative will enter your replacement order and provide you with a Return Goods Authorization (RGA) in order to return the stainless steel anchor shackles being replaced. This is required to confirm the units have been removed from service. No product should be returned without a Returned Goods Authorization. All products to be replaced MUST be returned to Miller Fall Protection, 1345 15<sup>th</sup> Street, Franklin, PA 16323






#### SKYGRIP KIT LAYOUT
